Dear Friends,

It goes without saying that it is an extraordinarily challenging time in our state and our country, especially for those of us whose mission is providing essential health care services. Still it's worth taking a moment to reflect on the work of Care Synergy and our Affiliated nonprofit care organizations last year.

In 2019, Care Synergy marked the five-year anniversary of our innovative mission-support model for Affiliates.

Care Synergy began in 2014 when nonprofit hospice and palliative care providers along Colorado's Front Range gathered to discuss common issues and challenges. Since then, Care Synergy's network has grown from two organizations – The Denver Hospice and Halcyon Hospice and Palliative Care – to five Affiliate organizations, including Pathways, Pikes Peak Hospice and Palliative Care and, most recently, the Colorado Visiting Nurse Association.

The Care Synergy family has not only grown in size and geographic footprint, but also in the breadth and depth of services our Affiliate organizations provide to patients, families, payers and referral partners.

On any given day, our Affiliate organizations provide hospice care to nearly 1,200 patients, palliative care services to more than 1,000 patients, comprehensive home health and wellness care to more than 1,100 patients, and counseling to thousands of bereaved adults and children. The quality, compassionate care consistently provided by our Affiliates is nothing short of heroic.

The role of Care Synergy has been to provide critical support to Affiliate organizations and to be a catalyst for continuous improvement and growth. We believe we have developed the best organizational model in the country for nonprofit hospice, palliative and home health care.

The Care Synergy model supports each Affiliate as a leading provider in their community and to thrive and grow to serve more patients, clients and families. And when challenges emerge, Care Synergy has remained a constant, providing critical support and services in an ever-changing environment.

Care Synergy creates an opportunity for its Affiliate organizations to collaborate together and share and leverage best practices of course, the ultimate purpose of all this is to give Coloradans the quality, compassionate care they need.

Our five-year anniversary is an important milestone. Congratulations to all -- every staff member, every volunteer, every board member, every donor and every health care partner, all of whom help make this care possible.

Welcoming the Colorado Visiting Nurse Association

In the five years since our formation, Care Synergy has grown to include five Affiliate organizations. In November, we welcomed our newest member, the Colorado Visiting Nurse Association (VNA), in a partnership that significantly expands our scope of care.

"Adding Colorado VNA as an Affiliate is an exciting evolution for Care Synergy, which has traditionally been focused on nonprofit hospice and palliative care organizations. It enables our nonprofit network to expand to offer a fuller continuum of care delivered in patients' homes and in the community."

Colorado VNA is the state's largest home health agency, with annual revenues of \$19 million and approximately 300 employees serving more than a thousand patients each day, primarily in the Denver and Boulder metro areas.

By combining Colorado VNA's skilled home health, paraprofessional, wellness and end-of-life programs with Care Synergy's expertise in hospice and palliative care, we can provide a more comprehensive spectrum of services to patients, payers, and health systems.



This additional partnership makes all Care Synergy Affiliates more competitive in the marketplace where consolidation is accelerating, while strengthening our long-term financial health and stability.

And that in turn furthers our collective mission.

The Network Advantage: Care Synergy Helps Pathways Build for the Future

Pathways,
our hospice and
palliative care Affiliate in
northern Colorado, is embarking
on a major undertaking to meet the needs
of its growing community: building the first
stand- alone Inpatient Care Center for hospice
patients in Larimer and Weld Counties.

Care Synergy is pleased to support the project by providing building and finance expertise, as well as operational, fundraising and development support.

Like all of our Affiliates, Pathways is feeling the impact of population growth and demographic shifts in Colorado. For several years, Pathways has seen 10-15% increases annually in the number of patients who need their services.

Currently, Pathways has a partnership with the McKee Medical Center in Loveland, providing inpatient hospice care in a hospital setting.

The new Inpatient Care Center will immediately double the number of beds available in the area, and include space for future expansion. It will also allow Pathways to provide an improved, home-like environment for those patients with the most acute end-of-life needs.

This newly planned facility will be adjacent to Pathways' campus at 305 Carpenter Road, between Fort Collins and Loveland.

The design includes a stone façade, natural light, water elements, and lush landscaping inspired by the Rocky Mountains. Each of the 12 rooms will be large enough to accommodate groups of visitors, as well as family members who wish to stay overnight with a patient.

There will be access to outdoor garden spaces where patients will be able to enjoy the views from the comfort of their bed. There will also be a chapel, a communal kitchen where families can prepare meals together, areas for quiet reflection, and walkways throughout the site blending indoor and outdoor spaces.

As this major project progresses -- through the advanced planning stages to construction of the new Inpatient Care Center -- Care Synergy looks forward to continuing to support Pathways' bold vision to serve the community.

Respect




Service

REVENUE: \$91,678,606






Revenue and Expenses
